

SCOOBY SHACK RULES

1. Scooby Shack will call Veterinarian for proof and date of your dog's current vaccinations.
2. Signed copies of the SCOOPY SHACK Rules, Services Agreement and Guest Profile forms.

Vaccinations:

We require a verbal from the veterinarian indicating dates of vaccinations or sufficient immunity against Rabies (each year), DHPP (each year) and Bordetella each year.

Flea & Internal Parasite Control

All Dogs must have been treated with an effective form of flea control treatment. If external parasites are discovered upon check-in, dogs will be treated with an effective form of flea control at owner/guardian's expense. If internal parasites are discovered during a dog's stay, treatment charges may apply at the owner/guardian's expense.

Age/Sex

To join daycare, all dogs must be spayed or neutered, unless under 7 months of age. Once they are over 7 months of age they must be spayed or neutered in order to socialize with the other dogs in our daycare.

Temperament Interview

To ensure the safety of all other dogs and employees, all dogs must undergo a temperament interview before taking part in social activities at the Scooby Shack. Please note that the Scooby Shack has sole discretion on whether dogs may take part in social activities.

Hours + Late Pick-up Policies

Regular Daycare hours: Monday – Saturday 6:30 am – 6:30 pm
Drop off is always before 12:00 noon.

Daycare Late Policy

Dogs must be picked up by 7:00 p.m. Monday – Saturday (daycare is closed on Sundays). Late fees will apply to dogs that are picked up after 6:30. All daycare dogs MUST be picked up by 7:00 or they are subject to boarding overnight with fees.

Boarding Policy: Standard check-in may occur between 8am and 12pm Monday-Saturday. No boarding check-in on Sunday. Checkout is by 6:30pm on the departure day, seven days a week. Sunday boarding check-out is between 12:00 noon – 6:30 pm.

ASSUMPTION OF RISK

OWNER/GUARDIAN ACKNOWLEDGES AND IS AWARE THAT EMPLOYEES OF THE SCOOPY SHACK ARE NOT VETERINARIANS AND DO NOT HAVE BACKGROUNDS IN ANIMAL MEDICINE AND ARE NOT EXPECTED TO DIAGNOSE OR DETECT ILLNESSES IN THE GUESTS THAT ARE STAYING AT THE SCOOPY SHACK. IN ADDITION, OWNER/GUARDIAN ACKNOWLEDGES AND IS AWARE THAT VACCINES DO NOT PROTECT AGAINST ALL COMMUNICABLE ILLNESSES THAT MAY AFFECT A GUEST. OWNER/GUARDIAN ACKNOWLEDGES AND AGREES THAT THEY ARE ASSUMING (I) ALL RISK OF ILLNESS, DISEASE, HARM OR OTHERWISE TO THEIR DOG BY ALLOWING THEIR DOG TO STAY AT THE SCOOPY SHACK AND (II) ALL RISK OF DAMAGES CAUSED BY THEIR DOG TO OTHER DOGS, TO ANY SCOOPY SHACK EMPLOYEE, AGENT OR TO ANY SCOOPY SHACK ASSET AND THAT THE SCOOPY SHACK SHALL HAVE NO LIABILITY FOR ANY HARM TO SUCH DOG.
